POSITION SUMMARY Repairs and overhauls automobiles, equipment, trucks, and earth moving and road building machines. Under general supervision, will operate heavy construction equipment, driving trucks and operating other light equipment used in the repair and maintenance of streets, alleys, catch basins, water lines, and sewer lines; performs related work as required. Regular and predictable attendance.

ESSENTIAL FUNCTIONS OF THE POSITION

30% - Examines vehicle and discusses with Superintendent or Crew Chief Foreman, or Crew Chief, Division of Streets, nature and extent of damage or malfunction. Plans work procedure. Maintains records of repairs. Raises vehicle, with hydraulic jack or hoist. Removes and/or disassembles units such as engine, transmission, or differential and inspects part for wear. Repairs or replaces parts such as pistons, rods, gears, valves, and bearings. Overhauls or replaces carburetors, injectors, blowers, generators, distributors, starters, and pumps. Rebuilds parts such as crankshafts and cylinder blocks. Rewires ignition system, lights, and instrument panel. Changes, rotates, and balances tires. Adjusts brakes, repairs or replaces shock absorbers. Mends damaged body and fenders. Replaces and adjusts headlights, and installs and repairs accessories such as radios, heaters, mirrors, and windshield wipers.

- 15% Repairs and maintains streets, curbs, catch basins, and alleys; operates a leaf machine to remove leaves from city streets; seals cracks in concrete and asphalt; operates mechanized vacuum machine to clean catch basins, builds forms for concrete; finishes concrete surfaces; repairs catch basins using brick and mortar; operates a jackhammer, grader, and chain saw.
- 15% Mows weeds and grass; trims shrubs and trees; resods grass areas; operates a brush chipper to dispose of trees and branches; plows snow and/or spreads salt to city streets and municipal parking lots. Maintenance of buildings; washes and waxes equipment. Maintains roadway markings.
- 10% Install water taps, water valves, fire hydrants, and water main lines. Repair water main breaks, fix leaking service lines, fire hydrants, and valves. Flush fire hydrants, exercise valves, and dig up curb boxes. Perform regular maintenance on both reservoirs and water towers, which includes mowing the grass, trimming weeds, painting, replace broken or worn out equipment, and maintenance on the pumps and building.
- 10 % Repairs sewer mains. Installs new sewer mains. Cleans sewer lines. Constructs and repairs manholes. Repairs and maintains lift and pump station equipment.

10% - Must have computer skills to prepare and submit electronic reports. Stays current with all accepted regulations from State and US EPA. Knowledge of the hazards of this type of work and the safety precautions to avoid such hazards.

10% - When assigned, shall assist the Division of Water Distribution and Sewer Maintenance with the construction, repair, maintenance, and inspections of the work to be performed in the respected department. Performs underground utility locates for OUPS notices.

NON-ESSENTIAL FUNCTIONS OF THE POSITION This job description in no manner states or implies that these are only duties and responsibilities to be performed by this position. Percentage of duties and responsibilities can change by availability of work. Other duties may be assigned.

SUPERVISORY RESPONSIBILITIES This job has no supervisory responsibility.

QUALIFICATIONS To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

<u>CERTIFICATES</u>, <u>LICENSES</u>, <u>REGISTRATIONS</u> Possession of a valid State of Ohio motor vehicle operator's license. Possession of a Class A CDL with tanker and air brake endorsement; if applicant does not possess a Class A CDL, must obtain a Class A CDL with tanker and air brake endorsement within 180 days of employment / job transfer / promotion.
