AMENDING CHAPTER 1044 (SEWER CHARGES), SECTION 1044.02 (CONDITIONS OF SERVICE; RATE SCHEDULE) OF THE CODIFIED ORDINANCES OF THE CITY OF SHELBY, OHIO.

WHEREAS, it is necessary to amend Chapter 1044 (Sewer Charges), Section 1044.02 (Conditions of Service; Rate Schedule) to maintain a sustainable financial balance for the operation of the sewer fund; and

WHEREAS, the fund balance has endured a substantial decline in revenue from multiple factors including; the loss of leachate and septage deliveries, loss of revenue during Covid19 stay at home orders, a reduction in the quarterly Production Cost Adjuster (PCA) due to increased plant efficiencies, and the 2022 annual Consumer Price Index (CPI) adjustment per the maximum allowance by ordinance was below the reported percentage per the U.S. Bureau of Labor Statistics, Division of Consumer Prices and Price Indexes; and

WHEREAS, it is in the interest of the public health, safety, morals, and general welfare of the citizens of the City of Shelby that Chapter 1044 (Sewer Charges), Section 1044.02 (Conditions of Service; Rate Schedule) be amended to adjust the base rate schedule for sewer services from the current annual rate of \$1.3514 per 100 cubic feet to \$1.6550 per 100 cubic feet to maintain a financially sustainable fund balance as required for an enterprising utility service.

# NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SHELBY, OHIO, A MAJORITY ELECTED THERETO CONCURRING:

Section 1: That Chapter 1044 (Sewer Charges), Section 1044.02 (Conditions of Service; Rate Schedules) of the Codified Ordinances of the City of Shelby shall be amended to implement an adjustment to the annual base rate as follows:

#### § 1044.02 CONDITIONS OF SERVICE; RATE SCHEDULE.

The terms and conditions upon which the owners of lots and lands within and outside of the corporate limits of the city may connect to or receive the benefits of the sewerage system, either directly or indirectly, and the charges for the service, shall be as follows:

### (a) Domestic.

(1) Per dwelling unit inside the city limits, per month:

AMENDING SECTION 642.15 (PLACING SIGNS) OF CHAPTER 642 (OFFENSES RELATING TO PROPERTY) OF THE CODIFIED ORDINANCES OF THE CITY OF SHELBY, OHIO.

WHEREAS, it has become necessary to revise the ordinance concerning the posting of signs on utility poles within the city; and

WHEREAS, it is in the interest of the public health, safety, morals, and general welfare of the citizens of the City of Shelby that Codified Ordinance Section 642.15 be amended.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SHELBY, OHIO, A MAJORITY ELECTED THERETO CONCURRING:

Section 1: That Section 642.15 of the Codified Ordinances of the City of Shelby be amended to read as follows:

### § 642.15 PLACING SIGNS.

- (a) Except for government placed signs, no person shall place a sign or other material upon a city-owned pole, or upon any pole, fixture, apparatus, or tree located within a city right-of-way along a public thoroughfare.
- (b) Whoever violates this section is guilty of a minor misdemeanor.
- Section 2: That all other sections of Chapter 642 shall remain in full force and effect.
- Section 3: That all meetings and hearings concerning the adoption of this Ordinance have been in compliance with Codified Ordinance 220.01, Ohio Revised Code Section 121.22, and the Charter of the City of Shelby.
- Section 4: That this Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and the earliest period allowed by law.

# RESOLUTION NO.: 47 -2022 (Sponsor: Councilmember Roberts)

# AUTHORIZING THE MAYOR AS DIRECTOR OF PUBLIC SAFETY TO ENTER INTO A FIRE PROTECTION CONTRACT WITH SHARON TOWNSHIP.

WHEREAS, Sharon Township desires to obtain fire protection for its property and residents from the City of Shelby, Ohio Fire Department; and

WHEREAS, the City of Shelby, Ohio is willing and able to furnish said fire protection for Sharon Township; and

WHEREAS, it is in the interest of the public health, safety, morals, and general welfare of the citizens of the City of Shelby and the citizens of Sharon Township that the Mayor as Director of Public Safety enter into said agreement, to provide fire protection to the property and citizens of Sharon Township.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SHELBY, OHIO, A MAJORITY ELECTED THERETO CONCURRING:

Section 1: The City of Shelby, Ohio agrees to provide Sharon Township with fire protection by the City of Shelby's Fire Department for a period of five (5) years commencing October 1, 2022, and terminating on September 30, 2027, inclusive, at the following rates, payable in full within Thirty (30) days after the end contract year, upon submission of invoice:

October 1, 2022-September 30, 2023	\$73,700.00*
October 1, 2023-September 30, 2024	\$74,924.00*
October 1, 2024-September 30, 2025	\$63,672.48
October 1, 2025-September 30, 2026	\$64,945.93
October 1, 2026-September 30, 2027	\$66,244.85

<sup>\*(</sup>includes \$12,500.00 balloon payment each year for 1st and 2nd years)

Section 2: This contract cannot be terminated due to monetary consideration by either party.

Section 3: The City of Shelby, Ohio agrees that the Fire Department services provided to Sharon Township shall be equal to that provided to the property and people of the City of Shelby, Ohio.

Section 4: The City of Shelby, Ohio agrees to provide state certified fire inspectors to provide fire inspection to Sharon Township if requested by its Board of Trustees.

Section 5: Either the City of Shelby, Ohio or Sharon Township may terminate this agreement provided that it gives the other party written notice One Hundred Eighty (180) days before the date on which it wishes to terminate said agreement.

Section 6: That all meetings and hearings concerning the adoption of this Resolution have been in compliance with Codified Ordinance 220.01, Ohio Revised Code Section 121.22, and the Charter of the City of Shelby, Ohio.

Section 7: That this Resolution shall be in full force and effect from and after its passage, approval by the mayor, and the earliest period allowed by law.
