ORDINANCE NO. 35 -2025
(Sponsor: Councilmember McLaughlin)

VACATING A PORTION OF AN ALLEY RUNNING PARALLEL BETWEEN WEST TUCKER AVENUE AND EARL AVENUE WITHIN THE CITY OF SHELBY, RICHLAND COUNTY, OHIO.

WHEREAS, on the 6th day of October 2025, the Council of the City of Shelby adopted Resolution No. 31-2025 declaring its intent to vacate a portion of an alley running parallel between West Tucker Avenue and Earl Avenue; and

WHEREAS, notice of adoption of the above resolution has been given to the owners of property abutting said roadways effected by said resolution, notifying said property owners of the time and place at which objections could be presented to the Board of Revision of Assessments (pursuant to Section 105 of the Charter of the City of Shelby); and

WHEREAS, the Board of Revision of Assessments met on December 8, 2025 and voted to approve and recommend the vacation of a portion of an alley running parallel between West Tucker Avenue and Earl Avenue; said hearing and procedure being in accordance with the provisions of Section 105 of the Charter of the City of Shelby, Ohio; and

WHEREAS, this Council is satisfied that there is good cause for vacating said roadway hereinafter described and that said vacation will not be detrimental to the general interest and public welfare.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SHELBY, OHIO, A MAJORITY ELECTED THERETO CONCURRING:

Section 1: That a portion of an alley running parallel between West Tucker Avenue and Earl Avenue as set forth in the plat and legal description as prepared by Hanning Surveying, LLC- Matt Hanning, Registered Surveyor on August 14, 2025 is hereby vacated.

Section 2: That in accordance with Section 105 of the Charter of the City of Shelby, Ohio, the City shall retain any and all easements necessary for the maintenance of utilities currently located within said roadway.

Section 3: That all meetings and hearings concerning the adoption of this Ordinance have been in compliance with Codified Ordinance 220.01, Ohio Revised Code Section 121.22, and the Charter of the City of Shelby, Ohio.

Section 4: That this Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and the earliest period allowed by law.

ORDINANCE NO. 1 -2026

AMENDING ORDINANCE 38-2024 (ESTABLISHING WAGES FOR DEPARTMENT HEADS AND OTHER NON-CERTIFIED EMPLOYEES AND DECLARING AN EMERGENCY.

WHEREAS, on December 16, 2024, Ordinance 38-2024 was passed in order to establish wages for department heads and other certified employees; and

WHEREAS, it is in the interest of the public health, safety, morals, and general welfare of the citizens of the City of Shelby that Ordinance 38-2024 be amended so as to adjust the annual salary and hourly wage ranges set forth therein for department heads, superintendents, and other non-certified employees.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SHELBY, OHIO, A TWO-THIRDS (2/3) MAJORITY ELECTED THERETO CONCURRING:

Section 1: That, effective January 1, 2026, the salaries, hourly wages, and wage ranges for the positions set forth below shall be as follows:

A RESOLUTION FOR THE EMPLOYMENT OF RENWICK, WELSH & BURTON LLC AS LEGAL COUNSEL FOR 2026, AND DECLARING AN EMERGENCY.

WHEREAS, the City is in need of Legal Counsel for prosecution cases as needed for 2026;
and

WHEREAS, Renwick, Welsh & Burton LLC has agreed to be the City's Legal Counsel for prosecution cases as needed commencing January 1, 2026 and ending December 31, 2026.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SHELBY, OHIO A TWO-THIRDS (2/3) MAJORITY ELECTED THERETO CONCURRING:

Section 1: That Renwick, Welsh & Burton LLC is hereby retained as the City's Legal Counsel, with Attorney John D. Studenmund designated as Legal Counsel, for the City of Shelby, Ohio, for a period commencing on the 1st day of January 2026 and terminating on the 31st day of December 2026.

Section 2: That the duties of the Legal Counsel are: (1) to prosecute and defend legal criminal and traffic actions on behalf of the City as needed.

Section 3: That remuneration for the Legal Counsel shall be One Hundred Fifty Dollars (\$150.00) per hour, and it shall provide an itemized invoice to the City. The Legal Counsel is an independent contractor and shall receive no employment benefits.

Section 4: That all meetings and hearings concerning the adoption of this Resolution have been in compliance with Codified Ordinance 220.01, Ohio Revised Code Section 121.22, and the Charter of the City of Shelby, Ohio.

Section 5: That this Resolution is hereby deemed to be an emergency so as to meet the ongoing contractual and/or monetary obligations of the City of Shelby Ohio and, therefore, shall be in full force and effect from and after its passage, approval by the Mayor, and the earliest period allowed by law.
