AUTHORIZING THE MAYOR AS DIRECTOR OF PUBLIC SERVICE TO ACQUIRE RIGHTS OF EASEMENT FOR EXTENSION OF A SANITARY SEWER LINE FOR THE WAREHAM ROAD SANITARY SEWER EXTENSION PROJECT.

WHEREAS, in order to extend a sanitary sewer line for the Wareham Road Sanitary Sewer Extension Project, it is necessary to secure rights of easement across private acreage; and

WHEREAS, it is in the interest of the public health, safety, morals, and general welfare of the citizens of the City of Shelby that the Mayor as Director of Public Service be authorized to acquire rights of easement for the extension of a sanitary sewer line on Wareham Road.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SHELBY, OHIO, A MAJORITY ELECTED THERETO CONCURRING:

Section 1: That the Mayor as Director of Public Service be authorized to acquire rights of easement for the extension of a sanitary sewer line on Wareham Road as shown on Exhibit A.

Section 2: That all meetings and hearings concerning the adoption of this Resolution have been in compliance with Codified Ordinance 220.01, Ohio Revised Code Section 121.22, and the Charter of the City of Shelby, Ohio.

Section 3: That the Resolution shall be in full force and effect from and after its passage, approval by the Mayor, and the earliest period allowed by law.
